**OFFICE ORDER**

Subject to approval of the Syndicate, the Vice-Chancellor of the Jagannath University has hereby granted study leave with full pay to **Md. 4. That the application for extension of study leave beyond the sanctioned period should be made at least six months before the expiry of the sanctioned leave through the supervisor/tutor together with the progress reports of the applicant;
