OFFICE ORDER

The Jagannath University has hereby granted study leave without pay to **Nur-E-Makbul**, Lecturer, Department of Mass Communication & Journalism, Jagannath University, Dhaka, Bangladesh, for a period of 01 (one) year, i.e. from 05 August, 2017 to 04 August, 2018 to pursue Masters Program in the Department of Communication Studies, Kansas State University, USA, as per decision (decision no.-6) of the 74th meeting of the Syndicate of the Jagannath University held on 09 July, 2017 according to the following terms and conditions:

1. That he shall have to enter into an agreement with the University in non-judicial stamp paper in accordance with the approved terms and conditions before he proceed on leave. He shall bear all costs in this regard;
2. That his service during the study leave shall be governed as per Jagannath University rules;
3. That returning from study leave he must at once report his return from leave to the Registrar along with a course leaving certificate through the Chairman/Head of the Department/Office. He shall not be entitled to join duties before the termination of his leave without permission of the Vice-Chancellor;
4. That the application for extension of study leave beyond the sanctioned period should be made at least six months before the expiry of the sanctioned leave through the supervisor/tutor together with the progress reports of the applicant;
5. The Jagannath University shall not bear any expenses for the said study leave.
