OFFICE ORDER

Subject to approval of the Syndicate, the Vice-Chancellor of the Jagannath University has hereby granted study leave with full average pay to **Md. Mafizur Rahman**, Assistant Professor, Department of Public Administration, Jagannath University, Dhaka, Bangladesh, for a period of 01 (one) year, i.e. from 30 August, 2017 to 29 August, 2018 to pursue Ph.D Program in the Huazhong University of Science and Technology, China, according to the following terms and conditions:

1. That he shall have to enter into an agreement with the University in non-judicial stamp paper in accordance with the approved terms and conditions before he proceed on leave. He shall bear all costs in this regard;
2. That his service during the study leave shall be governed as per Jagannath University rules;
3. That returning from study leave he must at once report his return from leave to the Registrar along with a course leaving certificate through the Chairman/Head of the Department/Office. He shall not be entitled to join duties before the termination of his leave without permission of the Vice-Chancellor;
4. That the application for extension of study leave beyond the sanctioned period should be made at least six months before the expiry of the sanctioned leave through the supervisor/tutor together with the progress reports of the applicant;
5. The Jagannath University shall not bear any expenses for the said study leave.
