OFFICE ORDER

Subject to approval of the Syndicate, the Vice-Chancellor of the Jagannath University has hereby granted study leave with full pay to **Md. Miraj Hossen**, Assistant Professor, Department of Management Studies, Jagannath University, Dhaka, Bangladesh, for a period of 01 (one) year, i.e. from 24 August, 2016 to 23 August, 2017 to pursue Ph.D Program in the Huazhong University of Science & Technology, China, according to the following terms and conditions:

1. That he shall have to enter into an agreement with the University in non-judicial stamp paper in accordance with the approved terms and conditions before he proceed on leave. He shall bear all costs in this regard;

3. That returning from study leave he must at once report his return from leave to the Registrar along with a course leaving certificate through the Chairman/Head of the Department/Office. 4. That the application for extension of study leave beyond the sanctioned period should be made at least six months before the expiry of the sanctioned leave through the supervisor/tutor together with the progress reports of the applicant;
5. The Jagannath University shall not bear any expenses for the said study leave.
