





OFFICE ORDER

Subject to the approval of the Syndicate, the Vice-Chancellor of Jagannath University has hereby granted study leave with pay to **Professor Dr. S M Masum Billah**, Department of Law, Jagannath University, Dhaka, Bangladesh, for a period of 07 (Seven) months, i.e. from 25 February, 2025 to 25 September, 2025 to participate Post-Doctoral program as visiting fellow, at Université Côte d'Azur, at the Institut de la Paix et du Developpment (IdPD) and Laborator, France, according to the following terms and conditions:

1. That he will have to enter into an agreement with the University in non-judicial stamp paper in accordance with the approved terms and conditions before he proceed on study leave. He will bear all the costs in this regard;
2. That his service during the study leave will be governed as per Jagannath University rules;
3. That returning from study leave he must at once report his return from leave to the Registrar along with a course leaving certificate through the Chairman/Head of the Department/Office. He will not be entitled to join his duties before the termination of his leave without permission of the Vice-Chancellor;
4. The Jagannath University will not bear any expenses for the aforementioned study leave.
