

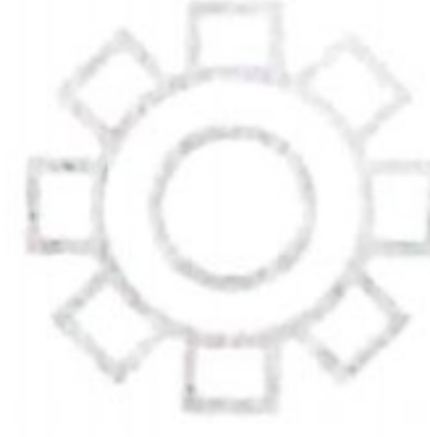
OFFICE ORDER
