**OFFICE ORDER**

Subject to approval of the Syndicate, the Vice-Chancellor of the Jagannath University has hereby granted study leave with pay to **Choyon Kumar Saha**, Assistant Professor, Department of Sociology, Jagannath University, Dhaka, Bangladesh, for a period of 01 (one) year, i.e. from 31 August, 2019 to 30 August, 2020 to pursue Ph.D Program in the University of Waterloo, Canada, according to the following terms and conditions:

4. That the application for extension of study leave beyond the sanctioned period should be made at least six months before the expiry of the sanctioned leave through the supervisor/tutor together with the progress reports of the applicant;
