**OFFICE ORDER**

Subject to approval of the Syndicate, the Vice-Chancellor of the Jagannath University has hereby granted lien leave (without pay) to **Professor Dr. Md. Ali Noor**, Department of Accounting and Information Systems, Jagannath University, Dhaka, for a period of 04 (four) years, i.e. from 01 October, 2020 to 30 September, 2024 to join as the Pro-Vice Chancellor of the Bangladesh University of Business and Technology, Mirpur, Dhaka, according to the following terms and conditions:
