





**OFFICE ORDER**

The Jagannath University has hereby granted study leave with pay to **Md. Zakaria Khan**, Assistant Professor, Department of Mass Communication & Journalism, Jagannath University, Dhaka, Bangladesh, for a period of 01 (one) Year, i.e. from 07 August, 2023 to 06 August, 2024 to pursue Master's Program in the University of South Florida, United States of America (USA) as per decision (decision no. 6) of the 95<sup>th</sup> meeting of the Syndicate of the Jagannath University held on 03 April, 2024 according to the following terms and conditions:

1. That he shall have to enter into an agreement with the University in non-judicial stamp paper in accordance with the approved terms and conditions before he proceed on leave. He shall bear all costs in this regard;
2. That his service during the study leave shall be governed as per Jagannath University rules;
3. That returning from study leave he must at once report his return from leave to the Registrar along with a course leaving certificate through the Chairman/Head of the Department/Office. He shall not be entitled to join duties before the termination of his leave without permission of the Vice-Chancellor;
4. That the application for extension of study leave beyond the sanctioned period should be made at least six months before the expiry of the sanctioned leave through the supervisor/tutor together with the progress reports of the applicant;
5. The Jagannath University shall not bear any expenses for the said study leave.


