

OFFICE ORDER

Subject to approval of the Syndicate, the Vice-Chancellor of the Jagannath University has granted leave to **Md. Kamruzzaman**, Assistant Professor, Department of Statistics, Jagannath University, Dhaka for a period of 01(one) year & 03(three) days, i.e. from (29/08/2018 to 31/08/2018, 03 days permission to station leave during the vacation of Eid-ul-Azha to visit and stay in South Korea & 01/09/2018 to 31/08/2019, 01 year study leave with pay) to participate in the Ph.D Program in Statistics under Seoul National University, South Korea, according to the following terms and conditions:

1. That he shall have to enter into an agreement with the University in non-judicial stamp paper in accordance with the approved terms and conditions before he proceeds on leave. He will bear all costs in this regard;
2. That his service during the study leave shall be governed as per Jagannath University rules.
3. That returning from study leave he must at once report his return from leave to the Registrar along with a course leaving certificate through the Chairman/Head of the Department/Office. He will not be entitled to join duties before the termination of his leave without the permission of the Vice-Chancellor;
4. That the application for extension of study leave beyond sanctioned period should be made at least six months before the expiry of the sanctioned leave through the supervisor/tutor together with the progress reports of the applicant;
5. That Jagannath University shall not bear any expenses for the said study leave.
