

OFFICE ORDER

Subject to approval of the Syndicate, the Vice-Chancellor of the Jagannath University has granted study leave with pay to Promi Halder, Assistant Professor, Department of Physics, Jagannath University, Dhaka for a period of 01(one) year i.e. from 02/01/2024 to 01/01/2025 to participate in the Ph.D Program at the Indian Institute of Technology, Jodhpur, India, according to the following terms and conditions:

- 4. That the application for extension of study leave beyond sanctioned period should be made at least six months before the expiry of the sanctioned leave through the supervisor/tutor together with the progress reports of the applicant;
- 5. That Jagannath University shall not bear any expenses for the said study leave.
